- 1. This notification and application have also been uploaded on the official website of IIT Jodhpur *http://www.iitj.ac.in*.
- 2. The applications are invited online in prescribed proforma (as per Annexure-I) from the Advocate(s) / Law Firm(s) possessing requisite qualifications and experience (as per Annexure-II), Applications received through email shall only be entertained.
- 3. Eligible candidates must submit the application in prescribed proforma (as per Annexure I & II) along with an Undertaking (as per Annexure-III) through email to registrar@iitj.ac.in and legalcell@iitj.ac.in in clear scanned single PDF format (not in JPG/JPEG format, etc.) latest by 31st October, 2025.
- 4. The application(s) shall be scrutinized by the Institute.
- 5. Eligibility criteria of Advocate(s)/Law Firm(s) i.e.
 - (i) The Advocate or representative partner/member of the Law firm shall possess a professional degree in Law from a recognized University/Institute and should be enrolled as an Advocate with Bar Council.
 - (ii) Advocate(s)/Law Firm(s) to be eligible for empanelment shall have active practice in the respective Court/Tribunals/Forums for at least 05 years at the



bar and within the Jurisdiction of the Jodhpur.

- (iii) The Advocate(s)/Law Firm(s) must have relevant experience and expertise in Civil Cases, Criminal Cases, Service Laws, Labour Laws, Taxation Laws, Consumer Forums, Public Premises & Eviction Laws and other Acts, Rules and Regulations relating to educational Institutions, Service matters or otherwise.
- (iv) The Advocate(s)/Law Firm(s) should be well versed with the Institutes of Technology Act, 1961/The Institutes of Technology (Amendment) Act (2012) and the Statutes, Rules and Regulations framed there under.
- (v) Advocate(s)/Law Firm(s) must have adequate infrastructure including Office, Computer with e-mail facility, well maintained Law journal/library etc.
- (vi) Preference shall be given to Advocate(s)/Law Firm(s) having more relevant experience and having exposure in dealing with matters on behalf of educational Institute/University.
- 6. IIT Jodhpur shall conduct an interaction/interview/presentation of short-listed Advocate(s) / Law Firm(s) fulfilling the eligibility criteria.
- 7. In respect of any clarification, the decision of IIT Jodhpur shall be final.
- 8. An Advocate(s) / Law Firm(s) will submit application for empanelment at IIT Jodhpur. However, final decision for empanelment shall be at the discretion of IIT Jodhpur.
- 9. The short-listed candidates shall be intimated on their Email Id for the purpose of interaction on specific date/s.
- 10. Fees:- Selected Advocate(s)/Law Firm(s) shall be empaneled as the Counsel of the Institute. Following rates per case shall be paid to them:

11. **i) Supreme Court:** The fee for Senior Advocate and Advocate on record shall be decided mutually at the time of need with the approval of Competent Authority.



- **ii) Special Case:** Cases which are important from the point of view of the institute, the fee payable to Advocate(s)/Law Firm(s) may be fixed mutually depending on the case, with the approval of Competent Authority.
- 12. Period, termination, resignation and expiry of term:
 - a. The Advocate(s)/Law Firm(s) shall be empaneled for the period of three years which may further be extended on yearly basis at the discretion of the Institute.
 - b. The counsel may resign from the empanelment by giving notice of minimum period of three months.
 - c. The name of any Advocate/Law Firm may be removed from the panel at the discretion of the Institute with immediate effect.
- 13. After the approval of committee, the final list of empaneled Advocate(s)/Law Firm(s) will be prepared and intimated to the concerned.
- 14. The application should reach this office on or before 31st October, 2025, no application shall be entertained, received beyond the prescribed date.
- 15. It may please be noted that incomplete/unreadable applications, application submitted in other format and those who do not fulfill the requisite conditions during interaction/interview/presentation shall summarily be rejected.
