4.2	Discussion Items			
4.2.1	Transition Plans for migrating II year and III year Students of the B.Tech.			
	Programs in CS, EE, ME, BISS and SS from old program to the new program			
	The Senate approved the transition plan for migrating II year and III year Students of			
	the B.Tech. Programs in CS, EE, ME, BISS and SS from old program to the new			
	program. It recommended that for these students, the old method may be adopted for			
	(a) calculation of credits for courses, and (b) numbering of courses.			
4.2.2				
	The Senate agreed in-principle to recommend the starting of M.Sc. Program in Physics			
	and Chemistry in July 2015, with initial intake of 10 students. It suggested that the			
	following points may be addressed and the revised proposal be brought to the Senate:			
	(1)The programs be drawn up with the unique feature of immersion in leading industry			
	and R&D organizations; and			
	(2)The different M.Sc. Programs should have the same structure, namely number of			
	compulsory courses and elective courses, and minimum credits to be earned.

	The Senate approved the new courses of the B.Tech., M.Tech and Ph.D. Programs and			
	replacement of the earlier proposed course HS321 Writing in Newspapers by HS321			
	Culture, Art and Heritage of India. Also, the Senate desired that course content of each			
	courses should contain a textbook within list of references for all UG Courses and			
	eMaterials for all courses.			



4.2.4 Special Curriculum for Sunil Choudhary (Roll No. B14CS037), B.Tech. (CSE) student enrolled in July 2014 The Senate admitted the proposal, and suggested the following: (1) The total number of credits shall remain as that for the other students of the B.Tech. (CSE) Program; and (2) The Coordinator (Academics - UG Programs) should present in the next meeting the details of implementation of items (b) and (c) of the Agenda, namely on replacement laboratory oriented courses or laboratory components of certain courses with (i) Those that are of descriptive nature and of listening type, and with spoken tutorials developed at prestigious universities/institutes in India or abroad; and (ii) Mini-projects in consultation with the student.
