8. The value of executed work shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum calculated from the date of completion to last date of submission of financial bid.
9. IIT Jodhpur is committed to follow the principle of transparency, equity and competitiveness in public procurement. Before submission of bid each bid should sign integrity pact at respective places and submit the bid, if duly signed integrity pact is not submitted by bidder such bid shall not be considered.
10. Those contractors not registered on CPP Portal are required to get registered beforehand. If needed they can be imparted training on online bidding process as per details available on the website
11. The intending bidder must have valid class-III digital signature to submit the bid.
12. On opening date, the contractor can login and see the bid opening process. After opening the bids he will receive the competitor bid sheets.
13. Contractor can upload documents in the form of JPG format and PDF format.
14. Contractor must ensure to quote rate of each item, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0". Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO).
15. The department reserves the right to reject any prospective application without assigning any reason and to restrict the list of qualified contractors to any number deemed suitable by it, if too many bids are received satisfying the laid down criterion.
16. In e-Tendering intending bidder can quote his rates in figures only. The rates in words, amount of each item and total is generated automatically. Therefore, the rate quoted by the bidder in figures is to be taken as correct.
17. 18. The EMD in original shall be deposited by the lowest tenderer within a week after opening of financial bid failing which the tender shall be rejected.
19. Certificate of work experience and other documents as specified in the notice inviting tender shall be scanned and uploaded to the e-Tendering website within the period of bid submission. However, certified / original copy of all the scanned and uploaded documents as specified in web notice may be verified by the institute.
20. **The bid submitted shall become invalid if:**
  - i. The bidder does not upload all the documents (including GST registration) as stipulated in the bid document.
  - ii. The lowest bidder does not deposit original EMD declaration within a week of opening of tender.
  - iii. ## **Instructions for Online Bid Submission:**

As per the directives of Department of Expenditure, this tender document has been published on the Central Public Procurement Portal ([URL:http://eprocure.gov.in/eprocure/app](http://eprocure.gov.in/eprocure/app)). The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

### **REGISTRATION**

- 1) Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal ([URL:http://eprocure.gov.in/eprocure/app](http://eprocure.gov.in/eprocure/app)) by clicking on the link "Click here to Enroll". Enrolment on the CPP Portal is free of charge.
- 2) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 3) Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- 4) Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / TCS / nCode / eMudhra etc.), with their profile.
- 5) Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSCs to others which may lead to misuse.
- 6) Bidder then logs in to the site through the secured log-in by entering their userID / password and the password of the DSC / eToken.

### **SEARCHING FOR TENDER DOCUMENTS**

- 1) There are various search options built in the CPP Portal, to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, organization name, location, date, value, etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as organization name, form of contract, location, date, other keywords etc. to search for a tender published on the CPP Portal.
- 2) Once the bidders have selected the tenders they are interested in, they may download the required documents / tender schedules. These tenders can be moved to the respective 'My Tenders' folder. This would enable the CPP Portal to intimate the bidders through SMS / e-mail in case there is any corrigendum issued to the tender document.
- 3) The bidder should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification / help from the Helpdesk.

### **PREPARATION OF BIDS**

- 1) Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- 2) Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents

have to be submitted, the number of documents - including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.

- 3) Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF / XLS / RAR / DWF formats. Bid documents may be scanned with 100 dpi with black and white option.
- 4) To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use "My Space" area available to them to upload such documents. These documents may be directly submitted from the "My Space" area while submitting a bid, and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

### **SUBMISSION OF BIDS**

- 1) Bidder should log into the site well in advance for bid submission so that he/she upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- 2) The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.
- 3) Bidder has to select the payment option as "on-line" to pay the tender fee / EMD as applicable and enter details of the instrument. Whenever, EMD / Tender fees are sought, bidders need to pay the tender fee and EMD separately on-line through RTGS or scan copy of original demand draft (Refer to Schedule, Page No.2).
- 4) A standard BoQ format has been provided with the tender document to be filled by all the bidders. Bidders are requested to note that they should necessarily submit their financial bids in the format provided and no other format is acceptable. Bidders are required to download the BoQ file, open it and complete the white coloured (unprotected) cells with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the filename. If the BoQ file is found to be modified by the bidder, the bid will be rejected.

OR

In some cases, Financial Bids can be submitted in PDF format as well (in lieu of BOQ).

- 5) The server time (which is displayed on the bidders' dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The bidders should follow this time during bid submission.
- 6) All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the data. The data entered cannot be viewed by unauthorized persons until the time of bid opening. The confidentiality of the bids is maintained using the secured Socket Layer 128 bit encryption technology. Data storage encryption of sensitive fields is done.
- 7) The uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- 8) Upon the successful and timely submission of bids, the portal will give a successful bid submission message & a bid summary will be displayed with the bid no. and the date & time of submission of the bid with all other relevant details.
- 9) Kindly add scanned PDF of all relevant documents in a single PDF file of compliance sheet.

**Preamble**

WHEREAS the Principal / Owner has floated the Tender (NIT No. ....) (Hereinafter referred to as **“Tender/Bid”**) and intends to award, under laid down organizational procedure, contract for.....

hereinafter referred to as the **“Contract”**.

AND WHEREAS the Principal/Owner values full compliance with all relevant laws of the land, rules, regulations, economic use of resources and of fairness/transparency in its relation with its Bidder(s) and Contractor(s).

AND WHEREAS to meet the purpose aforesaid both the parties have agreed to enter into this Integrity Agreement (hereinafter referred to as **“Integrity Pact”** or **“Pact”**), the terms and conditions of which shall also be read as integral part and parcel of the Tender/Bid documents and Contract between the parties.

NOW, THEREFORE, in consideration of mutual covenants contained in this Pact, the parties hereby agree as follows and this Pact witnesses as under:

### **Article 1: Commitment of the Principal/Owner**

- 1) The Principal/Owner commits itself to take all measures necessary to prevent corruption and to observe the following principles:
  - (a) No employee of the Principal/Owner, personally or through any of his/her family members, will in connection with the Tender, or the execution of the Contract, demand, take a promise for or accept, for self or third person, any material or immaterial benefit which the person is not legally entitled to.
  - (b) The Principal/Owner will, during the Tender process, treat all Bidder(s) with equity and reason. The Principal/Owner will, in particular, before and during the Tender process, provide to all Bidder(s) the same information and will not provide to any Bidder(s) confidential / additional information through which the Bidder(s) could obtain an advantage in relation to the Tender process or the Contract execution.
  - (c) The Principal/Owner shall endeavor to exclude from the Tender process any person, whose conduct in the past has been of biased nature.
- 2) If the Principal/Owner obtains information on the conduct of any of its employees which is a criminal offence under the Indian Penal code (IPC)/Prevention of Corruption Act, 1988 (PC Act) or is in violation of the principles herein mentioned or if there be a substantive suspicion in this regard, the Principal/Owner will inform the Chief Vigilance Officer and in addition can also initiate disciplinary actions as per its internal laid down policies and procedures.

### **Article 2: Commitment of the Bidder(s)/Contractor(s)**

- 1) It is required that each Bidder/Contractor (including their respective officers, employees and agents) adhere to the highest ethical standards, and report to the Government / Department all suspected acts of **fraud or corruption or Coercion or Collusion** of which it has knowledge or becomes aware, during the tendering process and throughout the negotiation or award of a contract.
- 2) The Bidder(s)/Contractor(s) commits himself to take all measures necessary to prevent corruption. He commits himself to observe the following principles during his participation in the Tender process and during the Contract execution:
  - a) The Bidder(s)/Contractor(s) will not, directly or through any other person or firm, offer, promise or give to any of the Principal/Owner's employees involved in the Tender process or execution of the Contract or to any third person any material or other benefit which he/she is not legally entitled to, in order to obtain in exchange any advantage of any kind whatsoever during the Tender process or during the execution of the Contract.
  - b) The Bidder(s)/Contractor(s) will not enter with other Bidder(s) into any undisclosed agreement or understanding, whether formal or informal. This applies in particular to prices, specifications, certifications, subsidiary contracts, submission or non-submission of bids or any other actions to restrict competitiveness or to cartelize in the bidding process.
  - c) The Bidder(s)/Contractor(s) will not commit any offence under the relevant IPC/PC Act. Further the Bidder(s)/Contractor(s) will not use improperly, (for the purpose of competition or personal gain), or pass on to others, any information or documents provided by the Principal/Owner as part of the business relationship, regarding plans, technical proposals and business details, including information contained or transmitted electronically.
  - d) The Bidder(s)/Contractor(s) of foreign origin shall disclose the names and addresses of agents/representatives in India, if any. Similarly Bidder(s)/Contractor(s) of Indian Nationality shall disclose names and addresses of foreign agents/representatives, if any. Either the Indian agent on behalf of the foreign principal or the foreign principal directly could bid in a tender but not both. Further, in cases where an agent participate in a tender on behalf of one manufacturer, he shall not be allowed to quote on behalf of another manufacturer along with

the first manufacturer in a subsequent/parallel tender for the same item.

- e) The Bidder(s)/Contractor(s) will, when presenting his bid, disclose any and all payments he has made, is committed to or intends to make to agents, brokers or any other intermediaries in connection with the award of the Contract.
- 3) The Bidder(s)/Contractor(s) will not instigate third persons to commit offences outlined above or be an accessory to such offences.
- 4) The Bidder(s)/Contractor(s) will not, directly or through any other person or firm indulge in fraudulent practice **means a willful misrepresentation or omission of facts or submission of fake/forged documents in order to induce public official to act in reliance thereof, with the purpose of obtaining unjust advantage by or causing damage to justified interest of others and/or to influence the procurement process to the detriment of the Government interests.**
- 5) The Bidder(s)/Contractor(s) will not, directly or through any other person or firm use Coercive Practices (means the act of obtaining something, compelling an action or influencing a decision through intimidation, threat or the use of force directly or indirectly, where potential or actual injury may befall upon a person, his/ her reputation or property to influence their participation in the tendering process).

### **Article 3: Consequences of Breach**

Without prejudice to any rights that may be available to the Principal/Owner under law or the Contract or its established policies and laid down procedures, the Principal/Owner shall have the following rights in case of breach of this Integrity Pact by the Bidder(s)/Contractor(s) and the Bidder/ Contractor accepts and undertakes to respect and uphold the Principal/Owner's absolute right:

- 1) If the Bidder(s)/Contractor(s), either before award or during execution of Contract has committed a transgression through a violation of Article 2 above or in any other form, such as to put his reliability or credibility in question, the Principal/Owner after giving 14 days' notice to the contractor shall have powers to disqualify the Bidder(s)/Contractor(s) from the Tender process or terminate/determine the Contract, if already executed or exclude the Bidder/Contractor from future contract award processes. The imposition and duration of the exclusion will be determined by the severity of transgression and determined by the Principal/Owner. **Such exclusion may be forever or for a limited period as decided by the Principal/Owner.**
- 2) **Forfeiture of EMD/Performance Guarantee/Security Deposit:** If the Principal/Owner has disqualified the Bidder(s) from the Tender process prior to the award of the Contract or terminated/determined the Contract or has accrued the right to terminate/determine the Contract according to Article 3(1), the Principal/Owner apart from exercising any legal rights that may have accrued to the Principal/Owner, may in its considered opinion forfeit the entire amount of Earnest Money Deposit, Performance Guarantee and Security Deposit of the Bidder/Contractor.
- 3) **Criminal Liability:** If the Principal/Owner obtains knowledge of conduct of a Bidder or Contractor, or of an employee or a representative or an associate of a Bidder or Contractor which constitutes corruption within the meaning of IPC Act, or if the Principal/Owner has substantive suspicion in this regard, the Principal/Owner will inform the same to law enforcing agencies for further investigation.

### **Article 4: Previous Transgression**

- 1) The Bidder declares that no previous transgressions occurred in the last 5 years with any other Company in any country confirming to the anticorruption approach or with Central Government or State Government or any other Central/State Public Sector Enterprises in India that could justify his exclusion from the Tender process.
- 2) If the Bidder makes incorrect statement on this subject, he can be disqualified from the Tender process or action can be taken for banning of business dealings/ holiday listing of the Bidder/Contractor as deemed fit by the Principal/ Owner.

- 3) If the Bidder/Contractor can prove that he has resorted / recouped the damage caused by him and has installed a suitable corruption prevention system, the Principal/Owner may, at its own discretion, revoke the exclusion prematurely.

#### **Article 5: Equal Treatment of all Bidders/Contractors/Subcontractors**

- 1) The Bidder(s)/Contractor(s) undertake(s) to demand from all subcontractors a commitment in conformity with this Integrity Pact. The Bidder/Contractor shall be responsible for any violation(s) of the principles laid down in this agreement/Pact by any of its Sub-contractors/sub-vendors.
- 2) The Principal/Owner will enter into Pacts on identical terms as this one with all Bidders and Contractors.
- 3) The Principal/Owner will disqualify Bidders, who do not submit, the duly signed Pact between the Principal/Owner and the bidder, along with the Tender or violate its provisions at any stage of the Tender process, from the Tender process.

#### **Article 6- Duration of the Pact**

This Pact begins when both the parties have legally signed it. It expires for the Contractor/Vendor 09 Months after the completion of work under the contract or till the continuation of defect liability period, whichever is more and for all other bidders, till the Contract has been awarded.

If any claim is made/lodged during the time, the same shall be binding and continue to be valid despite the lapse of this Pacts as specified above, unless it is discharged/determined by the Competent Authority, I.I.T. Jodhpur.

#### **Article 7- Other Provisions**

- 1) This Pact is subject to Indian Law, place of performance and jurisdiction is the Headquarters of the Division of the Principal/Owner, who has floated the Tender.
- 2) Changes and supplements need to be made in writing. Side agreements have not been made.
- 3) If the Contractor is a partnership or a consortium, this Pact must be signed by all the partners or by one or more partner holding power of attorney signed by all partners and consortium members. In case of a Company, the Pact must be signed by a representative duly authorized by board resolution.
- 4) Should one or several provisions of this Pact turn out to be invalid; the remainder of this Pact remains valid. In this case, the parties will strive to come to an agreement to their original intentions.
- 5) It is agreed term and condition that any dispute or difference arising between the parties with regard to the terms of this Integrity Agreement / Pact, any action taken by the Owner/Principal in accordance with this Integrity Agreement/ Pact or interpretation thereof shall not be subject to arbitration.

#### **Article 8- LEGAL AND PRIOR RIGHTS**

All rights and remedies of the parties hereto shall be in addition to all the other legal rights and remedies belonging to such parties under the Contract and/or law and the same shall be deemed to be cumulative and not alternative to such legal rights and remedies aforesaid. For the sake of brevity, both the Parties agree that this Integrity Pact will have precedence over the Tender/Contract documents with regard any of the provisions covered under this Integrity Pact.

1. Agency/ Firm shall abide by all laws of the land including, labour laws, Companies Act, Tax deduction liabilities, welfare measures of its employees and all other statutory obligations that enjoin in such cases and are not enumerated and defined herein, through any such onus shall be the exclusive responsibility of the Agency/ Firm, and it shall not involve the Institute in any way whatsoever.
2. The Financial Bid must be submitted in BOQ/Price Bid only.
3. Institute reserves the right to require the Agency/ Firm to remove any person deployed by the company, without assigning any reasons/notice. This will be without prejudice to the right of the Agency/ Firm to remove any of his own employees deployed in the Institute.
4. In the case of any dereliction of duty, negligence, an unintended or intended damage caused by the Agency/ Firm or its staff pertaining to this agreement, or otherwise, any harm is done to the Institute, the Agency/ Firm shall make good the loss or pay the compensation, refund expenditure on legal/judicial proceedings as well as pay such penalty which the party of the first part may deem fit.
5. It would be responsibility of Agency/Firm to arrange all permission/ approvals from all local bodies/statutory bodies & nothing extra shall be paid on account of this by the Institute.
6. The Agency/ Firm shall be responsible for all injury and accident to persons employed by him while on duty. It is desirable that all employees are covered under an insurance cover.

  22. Agency/ Firm must employ adult and skilled personnel only. Employment of child labour shall lead to the termination of the contract at the risk and cost of the Agency/ Firm. Agency/ Firm shall deploy/ engage reliable persons at client after proper character and police verification and impose any conditions as per prevailing contractual labour laws for such engagements, take disciplinary action or reward any person at work etc., at its sole costs, risks and responsibilities.
  23. Agency/ Firm shall deal with and settle the matters related with unions and shall make sure that no labour disputes / problems are referred to Client. It shall totally indemnify Client in this regard.
  24. Agency/ Firm should at all times indemnify Client against all claims, damages or compensation under the provisions of payment of wages Act, 1936; Minimum Wages Act, 1948; Employer's Liability Act, 1938 ; the workmen compensation Act, 1932 ; Industrial Disputes Act, 1947 ; Maternity Benefit Act, 1961 ; or any modification thereof or any other law relating thereto and rules made hereunder from time. Client will not own any responsibility in this regard.
  25. Tenderer should not have conflict of interest. The tenderer found to have conflict interest shall be disqualified.
  26. Joint ventures is not allowed.
  27. **No Rebate** on account of small scale industries or any other ground or on any other ground or documents shall be granted in this SPC/ Tender.
  28. All statutory & mandatory deductions as per Government of India & Rajasthan State Government norms shall be deducted from each running bill & final bill of agency/ firm.
  29. GST shall be applicable in this contract. NIT and the rules of Govt. of India of as notified from time to time shall be followed in items of GST. Presently, 18% GST has been considered in this tender and agency has to quote the rates inclusive of GST.
  30. No escalation clause i.e, clause 10CC of IITJ/CPWD GCC form 7/8 is applicable in this NIT/ Contract.
  31. **Security deposit @2.5% will be deducted for entire gross work done including extension period if any, from each installment however, earnest money deposit will be adjusted to security deposit.**
  32. 1% (one percent) cess towards labour welfare fund or as applicable, income tax as applicable and other taxes/ statutory recoveries as applicable will be deducted from the bill of contractor.
  33. Non-Judicial stamp paper worth Rs. 10/- (Ten Rupees only) will be submitted by contractor **which will have to be signed as token of acceptance.**
  34. No T & P would be supplied by the Institute and contractor will have to make his own arrangement.
  35. The contractors are advised to get acquainted with the proposed work including specifications & its site and additional conditions carefully before quoting. No claim of any sort shall be entertained or account of any site conditions and ignorance of specifications & additional conditions. The work shall be carried out as per the availability of site.
  36. The work shall be carried out as per CPWD specifications for civil and electrical work with up – to date correction slips unless otherwise specified in the nomenclature of individual item or in the specification, additional conditions where specifications are silent, the decision of Engineer-in-Charge shall be final and binding on contractor.
  37. The rates quoted by the contractor shall be taken as net and nothing extra shall be paid on any account i.e Royalty, Cartage, GST & stacking of material required at places etc. The rates for different items of

- work shall apply for Heights & Depths, Leads & Lifts unless otherwise specified in the agreement or specifications applicable in the agreement.
38. Articles manufactured by the reputed firms and approved make list in tender.
  39. The sample of material required in the work brought at site shall be got approved from Engineer –in-Charge before use in execution of work.
  40. All the required materials shall be got checked & approved by the Engineer-in-charge on receipt of the same at site before use and rejected material is to be removed from the site immediately.
  41. The sample of material required for Testing shall be provided at free of cost by the contractor. Testing charges if any shall be borne by the IIT Jodhpur if satisfactory report and if test results are unsatisfactory than testing charges shall be deducted from bills of contractor. All other expenditure to be incurred for taking sample, conveyance, packing etc. shall be borne by the contractor.
  42. The contractor shall submit a detailed program of work within 7 days of the date of award of work. The Engineer – in- Charge can modify the program and the contractors have to work accordingly.
  43. The contractor shall make his own arrangement for getting the permission with respect to trucks from the Traffic Police.
  44. No payment shall be made to contractor for any damage caused by the rain or any other natural causes what so ever during the execution of work.
  45. Some restrictions may be imposed by the security staff of IIT Jodhpur etc. on the working and on movement of labour & material. **No labour camp/ huts shall be allowed in IIT Jodhpur. The contractor shall make his own arrangement for labour huts outside the campus.** However, constructions of cement godown and Chowkidar's hut in the Campus shall be permitted. The contractor shall be bound to follow all such restrictions/ instructions and nothing shall be payable on this account.
  46. The contractor shall be fully responsible for the safe custody of the material issued or brought at site by him for doing the work.
  47. The Malba / Garbage generated at site due to construction activities shall be removed from the site immediately & shall be disposed off by the contractor to the approved dumping site of Jodhpur Municipal Corporation and all statutory approvals from local bodies shall be a sole responsibility of contractor.
  48. The contractor shall clean the site thoroughly of scaffolding materials, rubbish, equipment's left out of his work & dress the site around the building to the complete satisfaction of the Engineer-in-Charge before the work is treated as completed.
  49. Water charges @ 1% and Electricity charges @ 0.5 % of gross work done shall be deducted from bills of contractor if electricity and water provided by IIT Jodhpur for this work.
  50. Agency has to take proper safety measures during the execution of work.
  51. IITJ/CPWD GCC form 7/8 shall form part of NIT and the bidder shall go through GCC before quoting rates and the same shall be deemed to be accepted by bidder if he participates in the tender.
  52. ESI & EPF shall be reimbursed as per norms on production of original receipt of ESI & EPF from contractor specific to this work.
  53. The contractor shall submit the program of execution of work as per clause 5 of IITJ/CPWD GCC form 7/8 of NIT including list of workers to be deployed by contractor for this work.
  54. Contractor shall be responsible for keeping site free of any kind of mosquito breeding. If it is found that breeding is taking place the entire responsibility shall be of contractor to bear challan etc. done by local bodies.
  55. All the statutory obligations which is not covered in the bid document shall be reimbursed on actual basis after submission of proof of payment.
  56. The rates for different items of work shall apply for all Heights & Depths, Leads & Lifts unless otherwise specified in the agreement or specifications applicable in the agreement. The Agency/ Firm must visit site (internal or external) area before quoting rates.
  57. Final payment shall be released only after satisfactory completion of work.
  58. Failure to comply any of the above clauses or due to unsatisfactory performance as observed by Engineer-in-charge, the contract shall be terminated at any stage without assigning any reason thereof.

### **Additional Terms and Condition -**

1. The order of preference in case of any discrepancy as indicated in condition no. 1 under “Terms and Conditions of contract” given in the Standard CPWD Contract form may be read as the following:
  - a. Nomenclature of item as per Schedule of Quantities/ BoQ.
  - b. Additional specifications, particular specifications and special conditions for Electrical Works.
  - c. General conditions.
  - d. Contract Clauses of General conditions of contract for CPWD 2023.
  - e. CPWD specifications for electrical works 2023 part- I or as applicable.
  - f. Architectural/structural drawings and specifications mentioned in drawings.
  - g. Indian standard specifications of BIS.
  - h. Sound engineering practice as per directions of the Engineer-in-charge.
  - i. Manufacturer’s specifications.
2. A reference made to any Indian Standard Specifications in these documents, shall imply reference to the latest version of that standard, including such revisions/amendments as issued by the Bureau of Indian Standards upto last date of receipt of tenders. The contractor shall keep at his own cost all such publications of relevant Indian Standards applicable to the work at site.
3. The contractor shall take all safety precautions to avoid accidents by exhibiting caution boards, red flags, red lights and by providing necessary barriers and all other measures required from time to time. The contractor shall be responsible for all damages and accidents due to negligence on his part.
4. Even ISI marked materials shall be subjected to quality test at the discretion of the Engineer-in-charge besides testing of other materials as per the specifications described for the item/material. Whenever ISI marked materials are brought to the site of work; the contractor shall, if required by the Engineer-in-charge, furnish manufacturers test certificates to establish that the materials procured by the contractor for incorporation in the work satisfy the provisions of IS codes relevant to the material and/or the work done.
5. The contractor shall have to engage well experienced skilled labour and deploy modern T&P and other equipments to execute the work.
6. The contractor has to intimate his authorized representative, who will be receiving instructions in his absence. The contractor /his authorized representative is bound to sign the site order book as and when required by the Engineer-in-charge and to comply with the instructions therein.
7. All the work shall be carried out as per CPWD General specifications for the CPWD General Specifications for Electrical Works Part VIII Gas Based Fire Extinguishing System 2013 should also comply with relevant provisions of the Indian Electricity Rules / Acts as applicable, amended up to date.
8. The work is to be carried out to the entire satisfaction of the Engineer-in-charge and his authorized representative.
9. In case of any complaint against any of the personnel of the contractor, the said person will have to be replaced immediately by the contractor and the decision of the OIE, IIT Jodhpur in this regard shall be final and binding on the contractor.
10. In case of any disobedience by the staff of the contractor with the occupant’s/authorities/ Engineer-in-charge and his authorized representatives, the contractor shall be responsible fully for such consequences and such staff shall be removed from the site immediately.
11. The contractor shall maintain a logbook exhibiting all the checks, and faults with date and time. The logbook is to be provided by the contractor and the same shall be the property of the department after it is filled/or when work is completed.
12. The contractor shall have to arrange the tools and plants necessary for the maintenance of the work. Nothing extra shall be paid on account of tools, and plants required for the maintenance.
13. Boarding and lodging of the maintenance staff of the contractor will be the responsibility of the contractor. The arrangement will not be permitted inside the campus.



14. All taxes etc. should be included in the rates tendered. The Statutory deduction of contract tax at source shall be made while releasing payment through running/final bills. A certificate specifying the rate and amount of deduction shall however be issued by the department.
15. All equipments during transportation are to be kept clean and safe from the risk of Fire/Theft/Accidents and damage etc.
16. The contractor shall depute a qualified representative for the Joint Inspection of site whenever required for the state of prevailing conditions of maintenance and operation.
17. The contractor will keep the department indemnified against all losses or damage or liability arising out of/or imposed in the context of employment of person by him.
18. It shall be entirely the responsibility of the contractor to ensure that no unlawful act is done by his persons while on duty. In case any theft/ loss to the department's property due to the negligence or carelessness on part of staff employed by the contractor for the work the contractor shall be fully responsible and shall have to make good the same.
19. The Staff Employed by the contractor shall be at the sole responsibility and liability of contractor and they will be employee of the contractor and all expenses in connection with these Employees shall be borne by the contractor. Department shall not bear any liability what so ever with regard to these staff. The contractor shall provide at his own cost all statutory benefits to the staff employed by the contractor and department will not entertain any liability whatsoever on this account.
20. The contractor shall be solely responsible for compliance of various statutory obligation (including the financial liabilities) under the contractor labour regulation minimum wages act and other applicable laws and rules framed there from time to time.
21. The aforesaid mentioned terms & condition shall be read in conjunction with the general rules and direction for the guidance of contract.
22. Contractor shall inform the department well in advance in writing about the requirement of necessary spares and consumables items required in connection with the satisfactory operation/availability of the system services.
23. 1% labour cess or as applicable towards labour welfare fund etc. will be deducted from the bills of contractor on gross value of work bill.
24. Income tax/other taxes/statutory recoveries as applicable will be deducted from the bill.
25. The contractor shall be fully responsible for any damage caused to buildings, machinery, equipment's which are properties of the Department by any of his staff un-intentionally or willfully and shall be bound to make good the damage forth with failing which the Engineer- in-charge shall get damaged rectified /replaced at the contractor's risk and cost and the amount recovered from the contractor's dues.
26. The contractor is bound to sign the site order book as and when required by the engineer-in-charge and/or his authorized representative and carry out instructions received therein.
27. Bad workmanship whenever noticed and conveyed to the contractor, verbal or expressed, shall be rectified by the contractor at his own cost and to the satisfaction of the Engineer- in-Charge.
28. If any employee of the contractor goes to any court/conciliation officer/labour court or another legal authority etc. in or anywhere in India at any time under this contract the department shall not be made a party of it in any way by the employees of the contractor or by contractor himself. This fact should be clearly and legally told to all his employees by the contractor and the contractor shall be fully responsible for all losses/damages misconduct etc. arise on this contract.
29. The contractor shall pay all legal wages/dues/allowances to all his employees covered under this contract at all times and can quote his rates accordingly in this tender/offer. The contractor should not deny such things to any of his employees on the pretext that such things are not covered by the present contract/agreement.
30. The contractor shall give his telephones nos. both landline & mobile, and any change in them shall be informed to the department immediately.
31. It shall be binding upon the contractor to follow court-decisions & orders, without claim of any additional payment.
32. The staff employed by the contractor shall in no case will be eligible for absorbing in the department.

33. All the cleaning material i.e. soap, duster, Vacuum cleaner etc. shall be arranged by the contractor at his own cost.
34. Strict compliance with clauses 19, 19B and CPWD contractor's labour regulations, incorporated in "CPWD General Conditions of Contract" shall be ensured.
35. The contractor shall take all precautions for the safety of the workmen. If any accident/ mishap occurs, the department shall not be responsible for the same. Consequently, any compensation payable shall be at the contractor's cost.
36. The Contractor is fully responsible for the workmen deployed at site under this contract for safety, accident, any mishap occurs or any other unwanted misery at site. IITJ is not responsible/liable for any kind compensation, treatment or any kind of favour.
37. The contractor shall be responsible and liable for all omissions and acts of staff deployed by him.
38. Contractor has to ensure Mobile phone & sufficient balance amount of recharge value with employees deputed at site for proper communication. He has to give their mobile number to the concerned IITJ Engineers, nothing extra will be paid on this account.
39. The contractor will make his own arrangement for tools and plants or any other special tool may be necessary for the work.
40. The department is at liberty to discontinue the contract if the performance is not found satisfactory, in accordance with the terms and conditions without assigning any reason.
41. The firm shall Submit test report in format as given by Engineer-in- charge and get it signed through concerned IITJ Engineer.
42. The tendered rates shall be inclusive of all taxes (i.e. G.S.T.), duties and levies i/c cartage i/c any kind of increment in labour or material etc. Nothing shall be paid extra.
43. Minor materials such as painting of extinguishers, screws , Giti, and other accessories required for installation to be supplied by the contractor only.
44. Since the Installation is under the Defect Liability Period (01 year) it is the duty of the Contractor to Provide the details of the Defect that occurred of non-consumable items immediately to the IITJ Engineer of work. The DLP Agency shall provide the replacement of defective material and the Contractor has to install it on a timely basis.
45. Contractor and their Deputed staff shall abide by the COVID-19 Pandemic rule of Institute/ Disaster Management. The contractor shall take all safety to avoid contamination like keeping Sanitizers, thermal scanning etc. at the site. Nothing Extra shall be paid. The contractor will also follow the rules and regulations of the Rajasthan Government and District Administration of Jodhpur circular declared during the pandemic situation.
46. All the mandatory statutory compliance as applicable for all sub head mentioned in this document increase in minimum wages / like ESI/ PF/ Bonus/ Leave etc. has to be paid by agency and reimbursement of same shall be paid to agency as per actual on the production of original proof of payment.
47. Institute reserves the right to remove /reduced/or increases the scope of work at any time.
48. GCC and other relevant clauses / manuals of CPWD shall be part of this Tender document unless and otherwise specified.
49. Minimum billing an amount of Rs. 6,00,000/- (Rupees Six Lakh Only) should be produced by the concerned lowest agency to the department for payment process on a quarterly basis. The amount should be inclusive of GST.
50. The financial bid must be submitted in BOQ / price bid only.

## **TECHNICAL SPECIFICATIONS FOR Fire Extinguishers WORKS**

1. All fire extinguishers must be emptied a in the presence of OIE representative. If fire extinguishers get refilled in the City other than jodhpur city, then all expenses involved in the arrangement of traveling/staying etc. for IITJ representative shall be borne by the contractor/vendor itself.
2. Refilling work would be carried out in consultation with Office of Infrastructure Engineering Department at IIT Jodhpur. If any fire extinguisher fails in high pressure test as per Indian Standards (like IS 2171 or IS 10658) the discarded unit has to recorded and submitted back in Instituted with a metal tag of high pressures failed
3. The Fire Extinguisher should be examined internally for any damage & corrosion before re-filling.
4. Checking of nozzles, port hole, vent hole, cap assembly, siphon tube, safety pin/clip, discharge pipe etc. are be done prior to refilling
5. After refilling, paste inspection card to the body of fire extinguishers indicating the serial number, date of re-filling, next due date of re-filling, due date for high pressure testing etc. whatsoever required.
6. Ensure that all joints are fully tightened. And the nozzle and vent hole etc. are free from dust/dirt.
7. The contractor/vendor shall refill and repair the fire extinguisher free of cost within warranty time period of re-fill, if weight/pressure loss is noticed in the fire extinguisher which have been refilled by the contract.
8. The refilling of fire extinguisher shall have a warranty of 01 years from the date of refilling.
9. Random testing of the quality MAP powder at the time of refilling may be carried out by IIT Jodhpur authority at any authorized laboratory. If testing found fail, no payment will be made to the contractor for the work done. One or two fire extinguisher of each category should be tested to ensure satisfactory compliance and testing cost shall be borne by the contractor/vendor.
10. Replacement/repair of small spares like rings/washers/Nozzle or any other parts etc. has to be provided by the contractors free of cost (if required during the refilling of fire extinguisher).
11. Hydraulic testing/ High pressure testing certificate of fire extinguishers will be submitted along with bill and no extra charges shall be payable for the certificates as charges for the same are to be included in the Financial Bid.
12. The contractor shall refill the fire extinguisher as and when required by the IITJ without any objection, whether the quantity of fire extinguisher may be 10 (ten) at one time.
13. The quoted amount shall include all taxes like freight charges (to & fro upto workshop), loading, unloading, labour charges, GST, etc.
14. Loading or unloading of fire extinguishers/cylinders from each building/location/floor shall be done by contractor, who shall have refilled the fire extinguishers cartridge (without any extra cost implication).
15. Unless otherwise specified, All products/services for which BIS standards exist, should conform to the latest BIS standards.
16. In case of extinguishers covered by; Gas Cylinder Rules, stamp of approval should be embossed on the neck of cylinder.
17. The C02 cylinder should have certificate from Controller of Explosive Certificate (CCE) and the serial no should be embossed on the cylinder.
18. Record of replacement, refilling and supply of all the fire extinguishers shall be created building wise which include details such as location, type and capacity of extinguishers, date of refilling and next due date of refilling etc and provide the same to Institute. Also, a sticker of maintenance detail shall be put on each fire extinguisher as per the direction of EIC.
19. Hydrostatic Pressure Test (HPT), wherever due should be carried out in conformity with the procedure and periodic laid down in BIS 2190;2010. If fire extinguisher fails Hydraulic testing, then it will be replaced by new one after getting approval by EIC. The log sheet of hydraulic testing will be maintained by the vendor and shared with the Institute also.



20. The Contractor/Vendor shall ensure all safety measures for safe execution and the safety of the deployed workmen (as per applicable rules). The Contractor/Vendor shall be responsible for any Injury to their workmen during performing the servicing/refilling/maintenance work etc,
21. The vendor/contractor will follow BIS 2190:2010 for installation, testing, refilling and maintenance of fire extinguishers. The vendor may carry fire extinguisher to his own workshop for the same purpose only after taking prior approval of Institute.
22. The new fire extinguishers will be installed as per BIS 15683:2006 and as per the direction of EIC.
23. All the fire extinguishers must be discharged/emptied before refilling of fire extinguishers.
24. All fire extinguishers and refills and spare parts must confirm to performance and construction specifications as laid down IS 15683.2006 as amended from time to time by BIS.
25. All fire extinguishers will be provided with unique identification number (conspicuous location itched or punched protected for oxidation/rusting)
26. In case of refilling, the work includes
  - i) Examine the extinguisher body internally and externally for corrosion and damaged conditions with an illuminating probe.
  - ii) Proper cleaning of interior and exterior of fire extinguisher, polish the painted portion with wax polish, the brass/gun metal parts with metal polish, chromium plated parts with silver polish and plastic components to be thoroughly Washed with soap solution and sun dried.
  - iii) Painting of fire extinguisher body having rusting or paint coating failure on surface as per defined IS code.
  - iv) Replacement of old gas cartridge and extinguishing media of the fire extinguisher.
  - v) Checking of nozzles, port hole, vent hole, cap assembly, siphon tube, safety pin/clip. discharge pipe etc.
  - vi) Checking wall bracket/fire stand of fire extinguishers.
  - vii) After refilling paste inspection card to the body of the extinguishers indicating the serial number, date of refilling, next due date for refilling, due date for hydraulic testing etc.
  - viii) Ensure that all joints are fully tightened and nozzle, vent hole etc. are free of dust/dirt.
  - ix) Checking of pressure reading or indicator, it should be in operating range only.
27. Technical Specification for refiling of fire extinguisher
 

All fire extinguishers and refills and spare parts must confirm to performance and construction specifications as laid down IS 15683:2006 as amended from time to time by BIS.

**For Dry Power or ABC type fire extinguisher (4/5Kg or 6Kg):**

- i) The extinguisher shall be filled with ABC Grade 40, Mono Ammonium Phosphate (MAP base) from approved manufacturer/ dealer/firm.
- ii) The Capacity of the extinguisher when filled with Dry Chemical Powder (First filling) as per IS 4308, part II 8/ IS 15683, shall be 6Kg  $\Delta$  -2%.
- iii) It shall be pressurized with Dry Nitrogen, as expelling. The Nitrogen to be charged at a pressure of 15 kg / cm<sup>2</sup>.
- iv) The pressure gauge shall be suited for the purpose to discharge powder during the use.

**For water type extinguisher (Gas pressure type) (09 Liters), Mechanical Form Type (50 Liter):**

- i) The cartridge shall be as per IS, and have 60 gm net carbon dioxide gas for expelling.
- ii) Discharge should be not less than 06 meter, and continue so far at least for 60 sec.
- iii) The capacity of Extinguisher, when filled up to the indicated level, shall be 9 liters.

**For carbon dioxide type extinguisher (4.5kg):**

- i) The gas shall be conforming to IS: 307 and shall be stored at about 85 kg/cm<sup>2</sup>. The expansion ratio between stored liquid carbon dioxide to expanded gas shall be 1:9 times and total discharge time shall be minimum 10 sec. and Maximum 25 sec.
