TERMS AND CONDITIONS

- 1. No T&P would be supplied by the institute and contractor will have to make own arrangement.
- 2. The contractors are advised to get acquainted with the proposed work including specifications & its additional conditions carefully before quoting. No claim of any sort shall be entertained on account of any site conditions, ignorance of specification & additional conditions. The work shall be carried out as per the availability of site.
- 3. Firms / Contractors must have completed satisfactorily one similar work of value not less than Rs. 6,23,272/- or two similar works each of value not less than Rs. 4,67,454/- or three similar works each of value not less than Rs. 3,11,636/- during the last 7 years ending on date 31.10.2025.
 - Similar work means pertaining to SITC of water purification system & water cooler.
 - Completion certificate should be issued from Executive Engineer or higher level any of the Government organization/ CFTI/ Autonomous bodies only.
- 4. General condition of work shall be followed as GGC-2023 for works with amended correction slips up-to last date of submission of bid.
- 5. The rates quoted by the contractor shall be taken as net and nothing extra shall be paid on any account i.e. Royalty, Cartage, GST & Stacking of material required in place etc.
- 6. The rates for different items of work shall apply for all Heights & Depths, Leads & Lifts unless otherwise specified in the agreement or specifications applicable in the agreement.
- 7. Articles manufactured by the reputed firms and approved by Engineer-in -Charge shall only be used. Only articles classified as "First quality" by the manufacturer shall be used unless otherwise specified.
- 8. The sample material required in the work brought on at site shall be approved by the Engineer-in-Charge before use in execution of work.
- 9. The sample material required for testing shall be provided free of cost by the contractor. Testing charges, if any, shall be borne by the Institute. All other expenditure to be incurred on taking sample, conveyance, packing etc. shall be borne by the contractor.
- 10. The Engineer-in-Charge can modify the program, and the contractors must work accordingly. In case work does not start within 7 days the same is liable to be rescinded as per latest form 7/8 IITJ/CPWD and in case of delay liquidated damages to be imposed on contractors as per latest form 7/8 of IITJ/CPWD. Extension of time at work shall be dealt with as per latest form 7/8 of IITJ/CPWD.
- 11. The contractor shall be fully responsible for safe custody of the material issued or brought to the site by him for doing work.
- 12. Telegraphic, Postal & Conditional Quotation are liable to be summarily rejected.
- 13. Authority of IIT Jodhpur reserves the right to reject any or all the quotations without assigning any reason.
- 14. In case any dispute arises during the progress of the work, decision of Director, IIT Jodhpur, shall be final and binding on the contractor for the completion of work.
- 15. The contractor must visit the site of work / buildings before quoting the rates.
- 16. Site shall be made available as and when required by Department.
- 17. Site shall be available in parts or phases as per directions of Engineer-in-Charge.

- 18. Other deductions such as Income Tax (IT), GST TDS shall be deducted as per applicable law from the bill of contractors.
- 19. Time period for the execution of the work will be 1 Year days from the time of issue of the work order.
- 20. Earnest money and Tender fee in the form of Demand Draft or pay order or Banker's Cheque or Deposit at Call Receipt (drawn in favour of Director IIT Jodhpur,) as specified of any scheduled / Nationalized Bank or online and shall be submitted along with the tender / quotation documents.
- 21. **Delivery Time -** The supplier shall ensure delivery of the ordered items within 15 (fifteen) working days from the date of intimation of requirement communicated through email by the Institute. Such intimation should be treated as an official request for supply of the mentioned spare parts. Any delay in supply without prior written approval of the Institute may attract penalties as per the terms of the contract.
- 22. Liquidated Damage: If the contractor fails to supply the ordered items within 15 (fifteen) working days from the date of intimation of requirement communicated through email or before the stipulated delivery date, a penalty at the rate of 1% per week of the total value of that specific order shall be imposed, subject to a maximum of 10% of the total purchase order value.
- 23. **Payment Terms:** Payment shall be released only after the satisfactory delivery and inspection of the items supplied by the authority concerned at IIT Jodhpur. The payment will be processed on a part-supply basis, corresponding to each delivery. Material shall be procured from the OEM or authorized dealer, with necessary documents provided as proof of authenticity & submitted at IIT Jodhpur along with the materials every time.
- 24. **Supply Terms**: The supply of spare parts shall be made on a requirement/part basis as per the actual needs of the Institute. The supplier shall not be required to deliver all the listed items in a single lot. Instead, the requirement for individual parts or groups of parts shall be intimated through email by the Institute as and when required throughout the validity period of the tender. The supplier must ensure timely delivery of the items against each such email intimation as per the schedule mentioned therein.
